## **CFD FABULOUS FREESTYLE FUNDRAISER** **RIDER ENTRY INFORMATION**

### **MUSICAL FREESTYLE RIDE TIME CRITERIA**

To assist with scheduling, musical freestyle rides must not exceed the following maximum time limits: Individual rides: 6 minutes, Pas De Deux: 7 minutes, Quadrille: 10 minutes.

### **MUSICAL FREESTYLE LEVEL CRITERIA**

All levels of riders are welcome Intro – FEI Grand Prix. Choreography for rides do not have to strictly adhere to USDF Musical Freestyle required movements for each level. Riders may mix movements from different USDF or FEI levels.

Rides must be choreographed to music. Music must be appropriate for your ride and for general public listening and enjoyment.

Riders must bring their music on CD to the event. It must be delivered to the announcer's assistant, at the foot of the stairway to announcer's booth, at least 1 hour prior to your ride time (preferably earlier). **CD must be labeled with the rider's first and last name & horse's name or Act name (if group ride) as shown on your registration form.**

CFD will keep music CD's to assist in our preparation of the event DVD.

### **COSTUME CRITERIA**

Costumes are highly encouraged and should be appropriate to the theme of your music or ride. **Riders under the age of 21 are required to wear an ASTM/SEI certified helmet at all times while mounted.** Riders over 21 must wear an ASTM/SEI certified helmet at all times while mounted EXCEPT FOR during their actual performance in the show arena. Adult riders who choose to show their musical freestyle ride without a helmet do so at their own risk. All riders must wear standard riding boots or paddock boots with half chaps, either Western or English saddle and appropriate bridle with bit. **Riders are not allowed to wear masks or any kind of head covering which would obscure vision in any way.**

### **DVD**

A professional videographer will film all Fabulous Freestyle Fundraiser performances. CFD will create a DVD of the performances which will be available for sale. You may order a copy on or after the event date for \$20 This is a real deal since it will contain not just your ride, but all rides of the day. Shipping will be \$5.00 additional fee.
